RESOLUTION NO. 100 - 2021

DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE SUPPLY, DELIVERY, INSTALLATION, COMMISSIONING AND CONFIGURATION OF SENSORY PERIPHERALS AND RENOVATION OF THE URDANETA CONFERENCE ROOM FOR THE BUREAU'S NETWORK OPERATION CENTER (NOC)

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply, Delivery, Installation, Commissioning and Configuration of Sensory Peripherals and Renovation of the Urdaneta Conference Room for the Bureau's Network Operation Center (NOC) with an Approved Budget for the Contract (ABC) of Five Million Pesos (Php5,000,000.00), inclusive of all applicable taxes;

WHEREAS, on December 10, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 17, 2021, six (6) prospective bidders, namely, 1) Infobahn Communications, Inc., 2) Xtreme Works, Inc., 3) Stage Craft International, Inc., 4) AVLS All Visual and Lights System Corporation, 5) Avolution Inc. and 6) Datumstruct Philippines Inc. attended the Pre-bid Conference;

WHEREAS, Stage Craft International, Inc., submitted its Technical and Financial Bids, which, on December 28, 2021 was opened, read, and calculated as follows;

WHEREAS, pursuant to Resolution No. 68 - 2021 dated December 28, 2021, the BAC declared Stage Craft International, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification:

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Stage Craft International, Inc. found the same to be responsive and thereafter, declared Stage Craft International, Inc. as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee RESOLVED, as it hereby RESOLVES to:

a. declare Stage Craft International, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Supply, Delivery, Installation, Commissioning and Configuration of Sensory Peripherals and Renovation of the Urdaneta Conference Room for the Bureau's Network Operation Center (NOC);



- b. recommend the award for the Supply, Delivery, Installation, Commissioning and Configuration of Sensory Peripherals and Renovation of the Urdaneta Conference Room for the Bureau's Network Operation Center (NOC) for the Contract Price of Four Million Five Hundred Sixty-four Thousand Eight Hundred Eighty Pesos (Php4,564,880.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
