#### **CONTRACT AGREEMENT**

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  (PHP4,564,880.00), INCLUSIVE OF APPLICABLE TAX or such other sums as may be ascertained, STAGE CRAFT INTERNATIONAL INC. agrees to perform and deliver the "Supply, Delivery, Installation, Commissioning and Configuration of Sensory Peripherals and Renovation of the Urdaneta Conference Room for the Bureau's Network Operation Center (NOC)" in accordance with his/her/its accepted Bid/Quotation/Proposal.
- 4. The <u>BUREAU OF THE TREASURY</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.
