**RESOLUTION NO. 101 - 2021**

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)  
FOR THE SUPPLY OF LABOR, MATERIALS, TOOLS AND PROFESSIONAL  
SUPERVISION FOR THE REPAINTING OF EXTERIOR WALLS INCLUDING  
BASEMENT PARKING CURBS AND TRAFFIC ISLAND OF THE  
AYUNTAMIENTO BUILDING**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply of Labor, Materials, Tools and Professional Supervision for the Repainting of Exterior Walls Including Basement Parking Curbs and Traffic Island of the Ayuntamiento Building with an Approved Budget for the Contract (ABC) of Four Million Pesos (Php4,000,000.00), inclusive of all applicable taxes;

**WHEREAS**, on December 10, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on December 17, 2021, two (2) prospective bidders, namely, 1) MZR Builders and 2) JLG Painting Services attended the Pre-bid Conference;

**WHEREAS**, MZR Builders, submitted its Technical and Financial Bids, which, on December 28, 2021 was opened, read, and calculated as follows;

**WHEREAS**, pursuant to Resolution No. 69 - 2021 dated December 28, 2021, the BAC declared MZR Builders as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

**WHEREAS**, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by MZR Builders found the same to be responsive and thereafter, declared MZR Builders as the Single Calculated and Responsive Bidder (SCRB);


**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:


- a. declare MZR Builders as the Single Calculated and Responsive Bidder (SCRB) for the Supply of Labor, Materials, Tools and Professional Supervision for the Repainting of Exterior Walls Including Basement Parking Curbs and Traffic Island of the Ayuntamiento Building;


- b. recommend the award for the Supply of Labor, Materials, Tools and Professional Supervision for the Repainting of Exterior Walls Including Basement Parking Curbs and Traffic Island of the Ayuntamiento Building for the Contract Price of Three Million Seven Hundred Fifty Thousand Four Hundred Eighty Pesos & 2/100 (Php3,750,480.02), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.




