RESOLUTION NO. 70 - 2021

**DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID
FOR THE SUPPLY OF LABOR, MATERIALS, TOOLS/ EQUIPMENT, AND
PROFESSIONAL SUPERVISION FOR THE AUGMENTATION OF THE
SECURITY SURVEILLANCE SYSTEM OF THE AYUNTAMIENTO BUILDING**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee, invited prospective bidders to apply for eligibility and to bid for the Supply of Labor, Materials, Tools/ Equipment, and Professional Supervision for the Augmentation of the Security Surveillance System of the Ayuntamiento Building with an Approved Budget for the Contract (ABC) of Three Million Six Hundred Thirty-Six Thousand Three Hundred Twenty Pesos (Php3,636,320.00), inclusive of all applicable taxes;

WHEREAS, on December 13, 2021, the Invitation to Bid was posted through the Philippine Government Electronic Procurement System (PhilGEPS) and the BTr website;

WHEREAS, on December 20, 2021, three (3) prospective bidders, namely, 1) CVA Associates Philippines Company, 2) DGL Veracity Systems Corporation and 3) Guard-All Electronic Security Systems, Inc. attended the Pre-Bidding Conference;

WHEREAS, on December 29, 2021, Faxcable Inc. submitted its bid and participated in the Opening of Bids, but the bids submitted was not opened due to the bidder's failure to provide the password for the Technical and Financial Proposals thus, the BAC is constrained to declare a failure of bidding for the Supply of Labor, Materials, Tools/ Equipment, and Professional Supervision for the Augmentation of the Security Surveillance System of the Ayuntamiento Building;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Supply of Labor, Materials, Tools/ Equipment, and Professional Supervision for the Augmentation of the Security Surveillance System of the Ayuntamiento Building;
- b. recommend the re-bid of the Supply of Labor, Materials, Tools/ Equipment, and Professional Supervision for the Augmentation of the Security Surveillance System of the Ayuntamiento Building; and


- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.


