RESOLUTION NO. 102 - 2021

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE DIGITIZATION SERVICE OF THE EXISTING DOCUMENTS OF THE
BUREAU OF THE TREASURY**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Digitization Service of the Existing Documents of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Seven Million Seven Hundred Thousand Pesos (Php7,700,000.00), inclusive of all applicable taxes;

WHEREAS, on December 13, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 20, 2021, nine (9) prospective bidders, namely, 1) Pinnacle Technologies Inc., 2) Outsourced Urban Planner and Management Consultancy Services, 3) ISI Icomteq Inc., 4) U-BIX Corporation, 5) CG Garcia Appraisal and Land Title Services Inc., 6) Multisys Technologies Corporation, 7) ePDS, Inc., 8) ePLDT, Inc. and 9) Metasystems Development, Inc. attended the Pre-bid Conference;

WHEREAS, Pinnacle Technologies Inc., submitted its Technical and Financial Bids, which, on December 29, 2021 was opened, read, and calculated as follows;

WHEREAS, pursuant to Resolution No. 71 - 2021 dated December 29, 2021, the BAC declared Pinnacle Technologies Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Pinnacle Technologies Inc. found the same to be responsive and thereafter, declared Pinnacle Technologies Inc. as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:


- a. declare Pinnacle Technologies Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Digitization Service of the Existing Documents of the Bureau of the Treasury;


- b. recommend the award for the Digitization Service of the Existing Documents of the Bureau of the Treasury for the Contract Price of Seven Million Four Hundred Ninety-nine Thousand Eight Hundred Ninety Pesos (Php7,499,890.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.


