DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) FOR THE PROCUREMENT OF CERTIFICATION AND RE-CERTIFICATION SERVICES FOR TREASURY QUALITY MANAGEMENT SYSTEM OF THE BUREAU OF THE TREASURY UNDER ISO 9001:2016 QUALITY MANAGEMENT SYSTEM

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Certification and Re-certification Services for Treasury Quality Management System of the Bureau of the Treasury under ISO 9001:2016 Quality Management System with an Approved Budget for the Contract (ABC) of One Million Seven Hundred Thousand Pesos (PHP1,700,000.00), inclusive of all applicable taxes;

WHEREAS, on December 1, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 9, 2022, four (4) prospective bidders, namely, 1) DQS Certification Philippines, Inc., 2) WQA Philippines, Inc., 3) SOCOTEC Certification Philippines, Inc. and 4) TÜV SÜD PSB Philippines, Inc. attended the Prebid Conference;

WHEREAS, two (2) bidders, namely, SOCOTEC Certification Philippines, Inc. and TÜV SÜD PSB Philippines, Inc. bought the bidding documents and submitted their Technical and Financial Bids which, on December 21, 2022 was opened, read, and calculated as follows;


WHEREAS, pursuant to Resolution No. 65 - 2022 dated December 21, 2022, the BAC declared SOCOTEC Certification Philippines, Inc. as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by SOCOTEC Certification Philippines, Inc. found the same to be responsive and thereafter, declared Integrated Computer Systems, Inc. as the Lowest Calculated and Responsive Bidder (LCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

a. declare SOCOTEC Certification Philippines, Inc. as the Lowest Calculated and Responsive Bidder (LCRB) for the Procurement of Certification and Re-





certification Services for Treasury Quality Management System of the Bureau of the Treasury under ISO 9001:2016 Quality Management System;

- b. recommend the award for the Procurement of Certification and Re-certification Services for Treasury Quality Management System of the Bureau of the Treasury under ISO 9001:2016 Quality Management System for the Contract Price of One Million Two Hundred Forty-Eight Thousand Six Hundred Forty Pesos (PHP 1,284,640.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
