**RESOLUTION NO. 103 - 2021** 

DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE SUPPLY, DELIVERY, INSTALLATION, COMMISSIONING AND CONFIGURATION OF ESSENTIAL VIDEO EQUIPMENT FOR THE REPLACEMENT OF THE AUDIO VISUAL (AV) SYSTEM AT THE OFFICE OF THE TREASURER OF THE PHILIPPINES (OTOP) BOARDROOM OF THE BUREAU OF THE TREASURY

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply, Delivery, Installation, Commissioning and Configuration of Essential Video Equipment for the Replacement of the Audio Visual (AV) System at the Office of the Treasurer of the Philippines (OTOP) Boardroom of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Three Million Pesos (Php3,000,000.00), inclusive of all applicable taxes:

WHEREAS, on December 13, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 20, 2021, five (5) prospective bidders, namely, 1) AVLS All Visual and Lights System Corporation, 2) Avolution Inc., 3) Stage Craft International Inc., 4) Microdata Systems and Management, Inc. and 5) JMS Technology and Supplies attended the Pre-bid Conference;

WHEREAS, two (2) bidders, namely, 1) AVLS All Visual and Lights System Corporation and 2) JMS Technology and Supplies bought the bidding documents and submitted their Technical and Financial Bids, however JMS Technology and Supplies was declared ineligible for its failure to comply with the Technical Proposal, therefore only the bid of AVLS All Visual and Lights System Corporation, on December 29, 2021 was opened, read, and calculated:

WHEREAS, pursuant to Resolution No. 72 - 2021 dated December 29, 2021, the BAC declared AVLS All Visual and Lights System Corporation as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by AVLS All Visual and Lights System Corporation found the same to be responsive and thereafter, declared AVLS All Visual and Lights System Corporation as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee RESOLVED, as it hereby RESOLVES to:

 a. declare AVLS All Visual and Lights System Corporation as the Single Calculated and Responsive Bidder (SCRB) for the Supply, Delivery, Installation, Commissioning and Configuration of Essential Video Equipment for the Replacement of the Audio Visual





- (AV) System at the Office of the Treasurer of the Philippines (OTOP) Boardroom of the Bureau of the Treasury;
- b. recommend the award for the Supply, Delivery, Installation, Commissioning and Configuration of Essential Video Equipment for the Replacement of the Audio Visual (AV) System at the Office of the Treasurer of the Philippines (OTOP) Boardroom of the Bureau of the Treasury for the Contract Price of Two Million Eight Hundred Ninety-Four Thousand Seven Hundred Seven Pesos & 20/100 (Php2,894,707.20), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
