#### **CONTRACT AGREEMENT**

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In consideration for the sum of <a href="PHILIPPINE PESO: TWO MILLION EIGHT HUNDRED NINETY-FOUR THOUSAND SEVEN HUNDRED SEVEN PESOS & 20/100 (PHP2,894,707.20), INCLUSIVE OF APPLICABLE TAX or such other sums as may be ascertained, AVLS ALL VISUAL AND LIGHTS SYSTEM CORPORATION agrees to perform and deliver the "Supply, Delivery, Installation, Commissioning and Configuration of Essential Video Equipment for the Replacement of the Audio Visual (AV) System at the Office of the Treasurer of the Philippines (OTOP) Boardroom of the Bureau of the Treasury" in accordance with his/her/its accepted Bid/Quotation/Proposal.</a>
- 4. The <u>BUREAU OF THE TREASURY</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.
