RESOLUTION NO. 75 - 2022

**DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)
FOR THE SUPPLY AND DELIVERY OF FURNITURE FOR ASSET REGISTRY
DIVISION AND ACQUIRED ASSET MANAGEMENT DIVISION OFFICE
LOCATED ON THE 2ND FLOOR PALACIO DEL GOBERNADOR**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of Furniture for Asset Registry Division and Acquired Asset Management Division Office Located on the 2nd Floor Palacio Del Gobernador with an Approved Budget for the Contract (ABC) of Two Million Nine Hundred Thousand Pesos (PHP2,900,000.00), inclusive of all applicable taxes;

WHEREAS, on December 1, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 9, 2022, five (5) prospective bidders, namely, 1) LBPI Design International, Inc., 2) Progress Home & Office Furnishings, 3) Asahi Design Centre Inc., 4) Lee Designs Industries, Inc., and 5) Design Excellence Home and Office System Co. attended the Pre-Bid Conference;

WHEREAS, on December 14, 2022, Supplemental Bid Bulletin No. 42 - 2022 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

WHEREAS, three (3) bidders, namely, Progress Home & Office Furnishings, 2) Asahi Design Centre, and 3) Design Excellence Home and Office System Co. submitted their Technical and Financial Bids which, on December 21, 2022 was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 66 - 2022 dated December 21, 2022, the BAC declared Progress Home & Office Furnishings as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Progress Home & Office Furnishings found the same to be responsive and thereafter, declared Integrated Computer Systems, Inc. as the Lowest Calculated and Responsive Bidder (LCRB);



NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Progress Home & Office Furnishings as the Lowest Calculated and Responsive Bidder (LCRB) for the Supply and Delivery of Furniture for Asset Registry Division and Acquired Asset Management Division Office Located on the 2nd Floor Palacio Del Gobernador;
- b. recommend the award for the Supply and Delivery of Furniture for Asset Registry Division and Acquired Asset Management Division Office Located on the 2nd Floor Palacio Del Gobernador for the Contract Price of One Million Six Hundred Fifty-Nine Thousand One Hundred Nine Pesos and 90/100 (PHP1,659,109.90), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
