RESOLUTION NO. 112 - 2021

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR
THE SUPPLY AND DELIVERY OF ONE (1) LOT OF ALL-IN-ONE DESKTOP
COMPUTERS AND BUSINESS DESKTOP COMPUTERS, AND ONE (1) LOT OF
ADDITIONAL HEADSET AND WEBCAM TO THE BUREAU OF THE TREASURY
(LOT 1)**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of One (1) Lot of All-in-One Desktop Computers and Business Desktop Computers, and One (1) Lot of Additional Headset and Webcam to the Bureau of the Treasury (LOT 1) with an Approved Budget for the Contract (ABC) of Two Million Twenty-Five Thousand Pesos (Php2,025,000.00), inclusive of all applicable taxes;

WHEREAS, on December 13, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 21, 2021, three (3) prospective bidders, namely, 1) Integrated Computer Systems, Inc. 2) Quartz Business Products Corporation and 3) Wedingco Enterprise attended the Pre-Bidding Conference;

WHEREAS, Integrated Computer Systems, Inc., submitted its Technical and Financial Bids, which, on December 31, 2021 was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 81 - 2021 dated December 31, 2021, the BAC declared Integrated Computer Systems, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Integrated Computer Systems, Inc. found the same to be responsive and thereafter, declared Integrated Computer Systems, Inc. as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Integrated Computer Systems, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Supply and Delivery of One (1) Lot of All-in-One Desktop Computers and Business Desktop Computers, and One (1) Lot of Additional Headset and Webcam to the Bureau of the Treasury (LOT 1);
