## **CONTRACT AGREEMENT**

THIS AGREEMENT made on the 28<sup>th</sup> day of January 2022 between **BUREAU OF THE TREASURY**, with office address at Ayuntamiento Building, Cabildo Street corner Andres Soriano Avenue, Intramuros, Manila 1002 (hereinafter called "the Entity") of the one part and **INTEGRATED COMPUTER SYSTEMS, INC.** with office address at 3F Limketkai Bldg., Ortigas Ave., Greenhills, San Juan, Metro Manila (hereinafter called "the Supplier") of the other part;

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

Winning bidder<sup>5</sup> agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **PHILIPPINE PESO: ONE MILLION SIX** HUNDRED TWENTY-ONE THOUSAND EIGHT HUNDRED TWENTY (PHP1,621,820.00), INCLUSIVE OF APPLICABLE TAX or such other sums as may be ascertained, INTEGRATED COMPUTER SYSTEMS, **INC.** agrees to perform and deliver the "Supply and Delivery of One (1) Lot of All-in-One Desktop Computers and Business Desktop Computers, and One (1) Lot of Additional Headset and Webcam to the Bureau of the Treasury (LOT 1)" in accordance his/her/its with accepted Bid/Quotation/Proposal.
- 4. The <u>BUREAU OF THE TREASURY</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.
