RESOLUTION NO. 87 - 2022

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE PROCUREMENT OF VARIOUS FOOD ITEMS FOR THE BUREAU OF
THE TREASURY (CENTRAL AND NCR OFFICE)**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Various Food Items for the Bureau of the Treasury (Central and NCR Office) with an Approved Budget for the Contract (ABC) of Five Million Two Hundred Thirty-Five Thousand Pesos (PHP5,235,000.00), inclusive of all applicable taxes;

WHEREAS, on December 7, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 16, 2022, two (2) prospective bidders, namely, 1) Puregold Price Club, Inc. and 2) Ramesh Trading Corporation attended the Pre-bid Conference;

WHEREAS, Puregold Price Club, Inc., submitted its Technical and Financial Bids, which, on December 28, 2022 was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 86 - 2022 dated December 28, 2022, the BAC declared Puregold Price Club, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Puregold Price Club, Inc. found the same to be responsive and thereafter, declared Puregold Price Club, Inc. as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Puregold Price Club, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of Various Food Items for the Bureau of the Treasury (Central and NCR Office);
- b. recommend the award for Procurement of Various Food Items for the Bureau of the Treasury (Central and NCR Office) for the Contract Price of Five Million



Two Hundred Thousand One Hundred Pesos (PHP5,200,100.00), inclusive of all applicable taxes; and

- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
