RESOLUTION NO. 70 - 2022

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE PROCUREMENT OF MANAGED AND MAINTENANCE SERVICES FOR
SELECTED AUXILIARY SYSTEMS TO THE BUREAU OF THE TREASURY DATA
CENTERS**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Managed and Maintenance Services for Selected Auxiliary Systems to the Bureau of the Treasury Data Centers with an Approved Budget for the Contract (ABC) of Twenty Million Pesos (PHP20,000,000.00), inclusive of all applicable taxes;

WHEREAS, on November 23, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 1, 2022, two (2) prospective bidders, namely, 1) SMS Global Technologies, Inc. and 2) Multi-Fold Links, Inc. attended Pre-Bidding Conference;

WHEREAS, SMS Global Technologies, Inc. and Multi-Fold Links, Inc., submitted their Technical and Financial Bids on December 13, 2022;

WHEREAS, pursuant to Resolution No. 51 - 2022 dated December 13, 2022, the BAC declared SMS Global Technologies, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by SMS Global Technologies, Inc. found the same to be responsive and thereafter, declared SMS Global Technologies, Inc. as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare SMS Global Technologies, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of Managed and Maintenance Services for Selected Auxiliary Systems to the Bureau of the Treasury Data Centers;



- b. recommend the award for the Procurement of Managed and Maintenance Services for Selected Auxiliary Systems to the Bureau of the Treasury Data Centers for the Contract Price of Eighteen Million One Hundred Forty-One Thousand Fifty-Eight Pesos (PHP18,141,058.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
