**RESOLUTION NO. 03 - 2022**

**DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR THE  
SUPPLY OF LABOR, MATERIALS, TOOLS/ EQUIPMENT, AND PROFESSIONAL  
SUPERVISION FOR THE AUGMENTATION OF THE SECURITY SURVEILLANCE  
SYSTEM OF THE AYUNTAMIENTO BUILDING (RE-BID)**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply of Labor, Materials, Tools/ Equipment, and Professional Supervision for the Augmentation of the Security Surveillance System of the Ayuntamiento Building (Re-bid) with an Approved Budget for the Contract (ABC) of Three Million Six Hundred Thirty Six Thousand Three Hundred Twenty Pesos (Php3,636,320.00), inclusive of all applicable taxes;

**WHEREAS**, on March 29, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on April 6, 2022, three (3) prospective bidders, namely, 1) Compart Computer Sales, 2) DGL Veracity Systems Corporation and 3) Faxcable Inc. attended the Pre-bid Conference;

**WHEREAS**, on April 11, 2022, Supplemental Bid Bulletin No. 02-2022 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

**WHEREAS**, on April 19, 2022, during the scheduled Opening of Bids, only two (2) bidders, Compart Computer Sales and Faxcable Inc., submitted their bid, however, during the opening of their Technical Bid, Compart Computer Sales failed to comply with the requirements under Section VII. Technical Specifications particularly the Bidders Certification Requirement, while Faxcable Inc. failed to comply with the requirements under Section VI. Schedule of Requirements for failure to include the said document in their Bid;

**WHEREAS**, Notices of Post-Disqualification were issued to both bidders, and no Motion for Reconsideration was filed;

**WHEREAS**, after due consideration and deliberation, the BAC is constrained, and thus, resolved to declare a failure of bidding for the Supply of Labor, Materials, Tools/ Equipment, and Professional Supervision for the Augmentation of the Security Surveillance System of the Ayuntamiento Building (Re-bid) due to the ineligibility of the bidders during the preliminary examination;

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- b. recommend the re-bid of the Supply of Labor, Materials, Tools/ Equipment, and Professional Supervision for the Augmentation of the Security Surveillance System of the Ayuntamiento Building (Re-bid); and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
