RESOLUTION NO. 71 - 2022

DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE PROCUREMENT OF GOOGLE WORKSPACE LICENSES FOR THE OFFICIAL EMAIL OF THE BUREAU OF THE TREASURY

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Google Workspace Licenses for the Official Email of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Four Million Pesos (PHP4,000,000.00), inclusive of all applicable taxes;

WHEREAS, the Invitation to Bid (ITB) was posted on November 24, 2022 in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 2, 2022, four (4) prospective bidders, namely, 1) Universal Access and Systems Solutions Philippines, Inc., 2) MyBusyBee, Inc., 3) ePLDT, Inc. and 4) MaroonStudios, Inc. attended the Pre-bid Conference;

WHEREAS, MaroonStudios, Inc., submitted its Technical and Financial Bids, which, on December 14, 2022 was opened, read, and calculated;

WHEREAS, pursuant to Resolution No. 52 - 2022 dated December 13, 2022, the BAC declared MaroonStudios, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by MaroonStudios, Inc. found the same to be responsive and thereafter, declared MaroonStudios, Inc. as the Single Calculated and Responsive Bidder (SCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare MaroonStudios, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of Google Workspace Licenses for the Official Email of the Bureau of the Treasury;
- recommend the award for the Procurement of Google Workspace Licenses for the Official Email of the Bureau of the Treasury for the Contract Price of Three Million Seven Hundred Sixty Thousand Pesos (PHP3,760,000.00), inclusive of all applicable taxes; and
