**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE SUPPLY OF SERVICE FOR THE OPERATION AND PREVENTIVE
MAINTENANCE OF THE MECHANICAL, ELECTRICAL, PLUMBING AND FIRE
PROTECTION (MEPF) SYSTEMS OF THE AYUNTAMIENTO BUILDING AND AIR
HANDLING UNITS, COOLING TOWERS AND POWER AND DISTRIBUTION
SYSTEMS OF BTr OFFICES AT THE PALACIO DEL GOBERNADOR FOR FY
2024 / ITB-02-2024-G (EPA)**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply of Service for the Operation and Preventive Maintenance of the Mechanical, Electrical, Plumbing and Fire Protection (MEPF) Systems of the Ayuntamiento Building and Air Handling Units, Cooling Towers and Power and Distribution Systems of BTr Offices at the Palacio del Gobernador for FY 2024 with an Approved Budget for the Contract (ABC) of Thirteen Million Sixty Thousand Pesos (PHP 13,060,000.00), inclusive of all applicable taxes;

WHEREAS, on October 24, 2023, the Invitation to Bid (ITB) No. 02-2024-G (EPA) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on November 3, 2023, only one (1) prospective bidder, Renphil Trading, attended the Pre-bid Conference;

WHEREAS, on November 9, 2023, Supplemental Bid Bulletin No. 08-2023 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

WHEREAS, on November 16, 2023, Renphil Trading, submitted its technical and financial proposals through the e-bids@treasury.gov.ph;

WHEREAS, on November 16, 2023, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, pursuant to Resolution No. 21-2023 dated November 16, 2023, the BAC declared Renphil Trading, as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Renphil Trading, the BAC found the same to be responsive and recommends the award of the contract to Renphil Trading;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Renphil Trading, as the Single Calculated and Responsive Bidder (SCRB) for the Supply of Service for the Operation and Preventive Maintenance of the Mechanical, Electrical, Plumbing and Fire Protection (MEPF) Systems of the Ayuntamiento Building and Air Handling Units, Cooling Towers and Power and Distribution Systems of BTr Offices at the Palacio del Gobernador for FY 2024;
- b. recommend the award for the Supply of Service for the Operation and Preventive Maintenance of the Mechanical, Electrical, Plumbing and Fire Protection (MEPF) Systems of the Ayuntamiento Building and Air Handling Units, Cooling Towers and Power and Distribution Systems of BTr Offices at the Palacio del Gobernador for FY 2024 for the Contract Price of Thirteen Million Twenty-Three Thousand Six Hundred Seventy-Two Pesos (PHP 13,023,672.00), inclusive of all applicable taxes; and
- c. recommend the foregoing for the approval of the Officer-in-Charge - Bureau of the Treasury, as Head of the Procuring Entity (HOPE).
