**DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)  
FOR THE PREVENTIVE MAINTENANCE FOR THE VARIOUS AUDIO-VISUAL (AV)  
SYSTEM FACILITIES OF THE BUREAU OF THE TREASURY / ITB-03-2024-G (EPA)**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Preventive Maintenance for the Various Audio-Visual (AV) System Facilities of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Two Million Fifty Thousand Pesos (PHP 2,050,000.00), inclusive of all applicable taxes;

**WHEREAS**, on October 24, 2023, the Invitation to Bid (ITB) No. 03-2024-G (EPA) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

**WHEREAS**, on November 3, 2023, three (3) prospective bidders, namely, 1) JMS Technology and Supplies, 2) All Visual and Lights Systems Corporation., and 3) Avenue Media Corporation, attended the Pre-bid Conference;

**WHEREAS**, on November 16, 2023, two (2) bidders, namely, 1) JMS Technology and Supplies and 2) All Visual and Lights Systems Corporation, submitted their technical and financial proposals through the [e-bids@treasury.gov.ph](mailto:e-bids@treasury.gov.ph);

**WHEREAS**, on November 16, 2023, the submitted Technical and Financial Bids were opened, read, and calculated as follows:
