## **RESOLUTION NO. 54 - 2023**

### DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) FOR THE RENTAL OF MULTI-FUNCTION DIGITAL PHOTOCOPYING MACHINES FOR FY 2024 / ITB-04-2024-G (EPA)

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Rental of Multi-function Digital Photocopying Machines for FY 2024 with an Approved Budget for the Contract (ABC) of Two Million One Hundred Thousand Pesos (PHP 2,100,000.00), inclusive of all applicable taxes;

WHEREAS, on October 24, 2023, the Invitation to Bid (ITB) No. 04-2024-G (EPA) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

**WHEREAS**, on November 3, 2023, two (2) prospective bidders, namely, 1) U-Bix Corporation, and 2) Otus Copy Systems, Inc., attended the Pre-bid Conference;

WHEREAS, on November 16, 2023, two (2) bidders, namely, 1) U-Bix Corporation, and 2) Otus Copy Systems, Inc., submitted their technical and financial proposals through the <u>e-bids@treasury.gov.ph</u>;

**WHEREAS,** on November 16, 2023, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, pursuant to Resolution No. 23-2023 dated November 16, 2023, the BAC declared Otus Copy Systems, Inc., as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Otus Copy Systems, Inc., the BAC found the same to be responsive and recommends the award of the contract to Otus Copy Systems, Inc.;
