WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Antivirus Licenses and Support for Endpoint Protection of BTr Desktops and Laptops Bureau-wide with an Approved Budget for the Contract (ABC) of One Million Two Hundred Sixty Thousand Pesos (PHP 1,260,000.00), inclusive of all applicable taxes;

WHEREAS, on October 24, 2023, the Invitation to Bid (ITB) No. 05-2024-G (EPA) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

**WHEREAS**, on November 3, 2023, two (2) prospective bidders, namely, 1) Konek-IT Network Technologies, Inc, and 2) Infobahn Communications, Inc., attended the Pre-bid Conference:

**WHEREAS**, on November 16, 2023, Konek-IT Network Technologies, Inc., submitted its technical and financial proposals through the e-bids@treasury.gov.ph;

**WHEREAS,** on November 16, 2023, the submitted Technical and Financial Bids were opened, read, and calculated as follows:
