DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE PROCUREMENT OF MANAGED AND MAINTENANCE SERVICES FOR SELECTED AUXILIARY SYSTEMS FOR THE BUREAU OF THE TREASURY DATA CENTERS / ITB-06-2024-G (EPA)

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Managed and Maintenance Services for Selected Auxiliary Systems for the Bureau of the Treasury Data Centers with an Approved Budget for the Contract (ABC) of Twenty Million Pesos (PHP 20,000,000.00), inclusive of all applicable taxes;

WHEREAS, on October 25, 2023, the Invitation to Bid (ITB) No. 06-2024-G (EPA) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on November 06, 2023, two (2) prospective bidders, namely, 1) Multi-Fold Links, Inc. and 2) SMS Global Technologies Inc., attended the Pre-bid Conference;

WHEREAS, on November 17, 2023, only one (1) bidder: SMS Global Technologies Inc., submitted their technical and financial proposals through the <u>e-bids@treasury.gov.ph</u>;

WHEREAS, on November 17, 2023, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, pursuant to Resolution No. 28-2023 dated November 17, 2023, the BAC declared SMS Global Technologies Inc., as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by SMS Global Technologies Inc., the BAC found the same to be responsive and recommends the award of the contract to SMS Global Technologies Inc.;

- c. recommend the foregoing for the approval of the Officer in Charge Bureau of the Treasury as Head of the Procuring Entity (HOPE).
