RESOLUTION NO. 57-2023

**DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)
FOR THE SUPPLY AND INSTALLATION OF VARIOUS MANAGED SWITCHES FOR
THE BUREAU OF THE TREASURY / ITB-07-2024-G (EPA)**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Installation of Various Managed Switches for the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Eleven Million Nine Hundred Thousand Pesos (PHP 11,900,000.00), inclusive of all applicable taxes;

WHEREAS, on October 25, 2023, the Invitation to Bid (ITB) No. 07-2024-G (EPA) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on November 06, 2023, six (6) prospective bidders, namely, 1) American Technologies, Inc., 2) Remax International, Inc., 3) Integrated Computer Systems, Inc., 4) Horizon Gateway Corporation, 5) Infobahn Communications, Inc. and 6) Trends and Technologies, Inc. attended the Pre-bid Conference;

WHEREAS, on November 17, 2023, three (3) bidders, namely, 1) Integrated Computer Systems, Inc., 2) Infobahn Communications, Inc. and 3) Trends and Technologies, Inc. submitted their technical and financial proposals through the [e-bids@treasury.gov.ph](mailto:ebids@treasury.gov.ph);

WHEREAS, on November 17, 2023, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, pursuant to Resolution No. 29-2023 dated November 17, 2023, the BAC declared Integrated Computer Systems, Inc., as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) FOR THE SUPPLY AND INSTALLATION OF VARIOUS MANAGED SWITCHES FOR THE BUREAU OF THE TREASURY / ITB-07-2024-G (EPA)

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Integrated Computer Systems, Inc., the BAC found the same to be responsive and recommends the award of the contract to Integrated Computer Systems, Inc.;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Integrated Computer Systems, Inc., as the Lowest Calculated and Responsive Bidder (LCRB) for the Supply and Installation of Various Managed Switches for the Bureau of the Treasury;
- b. recommend the award for the Supply and Installation of Various Managed Switches for the Bureau of the Treasury for the Contract Price of Seven Million Four Hundred Thirty-Two Thousand Four Hundred Ninety-Five Pesos (PHP 7,432,495.00), inclusive of all applicable taxes; and
- c. recommend the foregoing for the approval of the Officer-in-Charge - Bureau of the Treasury as Head of the Procuring Entity (HOPE).
