DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE PROCUREMENT OF ONE (1) YEAR MAINTENANCE AGREEMENT FOR CORE SWITCH AND HYPER CONVERGED SERVERS FOR THE BUREAU OF THE TREASURY / ITB-08-2024-G (EPA)

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of One (1) Year Maintenance Agreement for Core Switch and Hyper Converged Servers for the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Five Million Two Hundred Thousand Pesos (Php5,200,000.00), inclusive of all applicable taxes;

WHEREAS, on October 26, 2023, the Invitation to Bid (ITB) No. 08-2024-G (EPA) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on November 06, 2023, only one (1) prospective bidder, Integrated Computer Systems, Inc., attended the Pre-bid Conference;

WHEREAS, on November 17, 2023, two (2) bidders, namely, 1) Integrated Computer Systems, Inc. and 2) Questech Co., Inc., submitted their technical and financial proposals through the <u>e-bids@treasury.gov.ph</u>;

WHEREAS, on November 17, 2023, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, the BAC resolved to declare Questech Co. Inc. ineligible for the project due to its non-compliance with the requirement that the bidder must have certified experts for HPE Simplivity, VMware and Aruba Switch;

WHEREAS, pursuant to Resolution No. 31-2023 dated November 17, 2023, the BAC declared Integrated Computer Systems, Inc., as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Integrated

- c. recommend the foregoing for the approval of the Officer-in-Charge Bureau of the Treasury as Head of the Procuring Entity (HOPE)
