## **RESOLUTION NO. 32 - 2023**

## DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR THE SUPPLY AND INSTALLATION OF A NETWORK DATA STORAGE SERVER FOR THE BUREAU OF THE TREASURY / ITB-09-2024-G (EPA)

**WHEREAS,** the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Installation of a Network Data Storage Server for the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Four Million Nine Hundred Thousand Pesos (PHP 4,900,000.00), inclusive of all applicable taxes;

WHEREAS, on October 26, 2023 the Invitation to Bid (ITB) No. 09-2024-G (EPA )was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on November 7, 2023, during the scheduled Pre-Bidding Conference, three (3) prospective bidders, namely 1) American Technologies Inc., 2) Integrated Computer Systems, Inc. and 3) Universal Access and Systems Solutions Phil Inc. attended;

WHEREAS, on November 20, 2023, only one (1) bidder, Integrated Computer Systems, Inc., submitted their technical and financial proposals through the <u>e-bids@treasury.gov.ph</u>, however, during the opening of its Technical Bid, Integrated Computer Systems, Inc., failed to comply with the requirements under ITB Clause 5.3 of the Bid Data Sheet. The Single Largest Completed Contract (SLCC) provided by ICS relates to Back-up Storage Solution which is merely a storage for data recovery and is not considered "similar" to the project to be bid that consists of centralized storage and access for multiple servers and other devices.;

WHEREAS, after due consideration and deliberation, the BAC is constrained, and thus, resolved to declare a failure of bidding for the Supply and Installation of a Network Data Storage Server for the Bureau of the Treasury due to the ineligibility of the bidder during the preliminary examination;

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Supply and Installation of a Network Data Storage Server for the Bureau of the Treasury;
- b. recommend the foregoing for the approval of the Officer-in-Charge Bureau of the Treasury as Head of the Procuring Entity (HOPE); and
