RESOLUTION NO. 59-2023

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE SUPPLY AND INSTALLATION OF HYPER-CONVERGED SERVER
FOR THE BUREAU OF THE TREASURY DR SITE / ITB-10-2024-G (EPA)**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Installation of Hyper-Converged Server for the Bureau of the Treasury DR Site with an Approved Budget for the Contract (ABC) of Nine Million Pesos (PHP 9,000,000.00), inclusive of all applicable taxes;

WHEREAS, on October 26, 2023, the Invitation to Bid (ITB) No. 10-2024-G (EPA) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on November 07, 2023, two (2) prospective bidders, namely, 1) Integrated Computer Systems, Inc. and 2) Universal Access and Systems Solutions Phil Inc., attended the Pre-bid Conference;

WHEREAS, on November 20, 2023, only one (1) bidder: Integrated Computer Systems, Inc., submitted their technical and financial proposals through the e-bids@treasury.gov.ph;

WHEREAS, on November 20, 2023, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, pursuant to Resolution No. 33-2023 dated November 20, 2023, the BAC declared Integrated Computer Systems, Inc., as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Integrated Computer Systems, Inc., the BAC found the same to be responsive and recommends the award of the contract to Integrated Computer Systems, Inc.;

- a. declare Integrated Computer Systems, Inc., as the Single Calculated and Responsive Bidder (SCRB) for the Supply and Installation of Hyper-Converged Server for the Bureau of the Treasury DR Site;
- b. recommend the award for the Supply and Installation of Hyper-Converged Server for the Bureau of the Treasury DR Site for the Contract Price of Eight Million One Hundred Twenty-Seven Thousand Three Hundred Sixty-Nine Pesos (PHP 8,127,369.00), inclusive of all applicable taxes; and
- c. recommend the foregoing for the approval of the Officer in Charge – Bureau of the Treasury as Head of the Procuring Entity (HOPE).
