## DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE SUPPLY, INSTALLATION AND COMMISSIONING OF ENTERPRISE BACKUP SYSTEM FOR THE BUREAU OF THE TREASURY / ITB-11-2024-G (EPA)

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply, Installation and Commissioning of Enterprise Backup System for the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Three Million Eighty Thousand Pesos (PHP 3,080,000.00), inclusive of all applicable taxes;

WHEREAS, on October 26, 2023, the Invitation to Bid (ITB) No. 11-2024-G (EPA) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

**WHEREAS**, on November 7, 2023, two (2) prospective bidders, namely, 1) Integrated Computer Systems, Inc., and 2) Universal Access and Systems Solutions Phil. Inc., attended the Pre-bid Conference;

**WHEREAS,** on November 13, 2023, Supplemental Bid Bulletin No. 12-2023 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

**WHEREAS**, on November 20, 2023, Integrated Computer Systems, Inc., submitted its technical and financial proposals through the <u>e-bids@treasury.gov.ph</u>;

**WHEREAS,** on November 20, 2023, the submitted Technical and Financial Bids were opened, read, and calculated as follows:
