RESOLUTION NO. 62-2023

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE PROCUREMENT OF GOOGLE WORKSPACE (GWS) LICENSES FOR
THE OFFICIAL EMAIL OF THE BUREAU OF THE TREASURY /
ITB-13-2024-G (EPA)**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Google Workspace (GWS) Licenses for the Official Email of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Five Million Eight Hundred Eighty Thousand Pesos (PHP 5,880,000.00), inclusive of all applicable taxes;

WHEREAS, on November 15, 2023, the Invitation to Bid (ITB) No. 13-2024-G (EPA) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on November 22, 2023, six (6) prospective bidders, namely, 1) Globe Telecom., 2) ePLDT Inc., 3) Q Software Research Corp., 4) LaQuest Philippines Inc., 5) Maroon Studios Inc., and 6) Crayon Software Experts Philippines Inc., attended the Pre-bid Conference;

WHEREAS, on December 4, 2023, two (2) bidders: ePLDT Inc., and LaQuest Philippines Inc., submitted their technical and financial proposals through the e-bids@treasury.gov.ph;

WHEREAS, on December 4, 2023, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, the BAC resolved to declare LaQuest Philippines, Inc. ineligible for the project due to its non-compliance with the requirement that the bidder is operating in the Philippines for the past five (5) years as an IT company;

WHEREAS, pursuant to Resolution No. 38-2023 dated December 4, 2023, the BAC declared ePLDT Inc., as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by ePLDT Inc., the BAC found the same to be responsive and recommends the award of the contract to ePLDT Inc.;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare ePLDT Inc., as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of Google Workspace (GWS) Licenses for the Official Email of the Bureau of the Treasury;
- b. recommend the award for the Procurement of Google Workspace (GWS) Licenses for the Official Email of the Bureau of the Treasury for the Contract Price of Five Million Pesos (PHP 5,000,000.00), inclusive of all applicable taxes; and
- a. recommend the foregoing for the approval of the Officer-in-Charge – Bureau of the Treasury as Head of the Procuring Entity (HOPE).
