DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE SUPPLY AND INSTALLATION OF ONE (1) YEAR LICENSES TO EXISTING VARIOUS SECURITY AND LOAD BALANCING EQUIPMENT OF THE BUREAU OF THE TREASURY'S ONLINE RESOURCES / ITB-16-2024-G (EPA)

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Installation of One (1) Year Licenses to Existing Various Security and Load Balancing Equipment of the Bureau of the Treasury's Online Resources with an Approved Budget for the Contract (ABC) of Three Million Seven Hundred Thousand Pesos (PHP 3,700,000.00), inclusive of all applicable taxes;

WHEREAS, on November 15, 2023, the Invitation to Bid (ITB) No. 16-2024-G (EPA) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

**WHEREAS**, on November 22, 2023, only one (1) prospective bidder, Secur Links Network and Technologies, Inc., attended the Pre-bid Conference;

**WHEREAS**, on December 4, 2023, one (1) bidder: Secur Links Network and Technologies, Inc. submitted its technical and financial proposals through the <u>e-bids@treasury.gov.ph</u>;

**WHEREAS,** on December 4, 2023, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

- a. recommend the foregoing for the approval of the Officer-in-Charge Bureau of the Treasury as Head of the Procuring Entity (HOPE).
