RESOLUTION NO. 68-2023

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE SUPPLY OF LABOR, MATERIALS AND TOOLS FOR THE
REPLACEMENT OF FLOOR TILES IN THE COMMON AREA ON THE GROUND
FLOOR OF THE AYUNTAMIENTO BUILDING / ITB-17-2024-I (EPA)**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply of Labor, Materials and Tools for the replacement of Floor Tiles in the Common Area on the Ground Floor of the Ayuntamiento Building with an Approved Budget for the Contract (ABC) of Three Million Pesos (PHP 3,000,000.00), inclusive of all applicable taxes;

WHEREAS, on December 5, 2023, the Invitation to Bid (ITB) No. 17-2024-I (EPA) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on December 12, 2023, two (2) prospective bidders, namely, 1) JEMN Builders, and 2) MZR Builders attended the Pre-bid Conference;

WHEREAS, on December 15, 2023, Supplemental Bid Bulletin No. 16-2023 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

WHEREAS, on December 22, 2023, only one (1) bidder, MZR Builders submitted its technical and financial proposals through the e-bids@treasury.gov.ph;

WHEREAS, on the same date, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, pursuant to Resolution No. 50-2023 dated December 22, 2023, the BAC declared MZR Builders, as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents

submitted by MZR Builders, the BAC found the same to be responsive and recommends the award of the contract to MZR Builders.;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare MZR Builders, as the Single Calculated and Responsive Bidder (SCRB) for the Supply of Labor, Materials and Tools for the replacement of Floor Tiles in the Common Area on the Ground Floor of the Ayuntamiento Building;
- b. recommend the award for the Supply of Labor, Materials and Tools for the replacement of Floor Tiles in the Common Area on the Ground Floor of the Ayuntamiento Building for the Contract Price of Two Million Nine Hundred Twenty Thousand Sixty-Seven Pesos and 69/100 (PHP 2,920,067.69), inclusive of all applicable taxes; and
- c. recommend the foregoing for the approval of the Officer-in-Charge – Bureau of the Treasury as Head of the Procuring Entity (HOPE)..
