TREASURY (BTr) / ITB-18-2024-G (EPA)**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Maintenance Support Services for Various Public Financial Management (PFM) Application Systems of the Bureau of the Treasury (BTr) with an Approved Budget for the Contract (ABC) of Eleven Million Seven Hundred Thousand Pesos (PHP 11,700,000.00), inclusive of all applicable taxes;

**WHEREAS**, on December 11, 2023, the Invitation to Bid (ITB) No. 18-2024-G (EPA) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

**WHEREAS**, on December 18, 2023, two (2) prospective bidders, namely, 1) Cyan Technologies Partners, Inc., and 2) Varo Technosolutions Inc., attended the Pre-bid Conference;

**WHEREAS**, on December 28, 2023, only one (1) bidder, The Joint Venture of Cyan Technologies Partners, Inc. and SMS Global Technologies, Inc., submitted its technical and financial proposals through the [e-bids@treasury.gov.ph](mailto:e-bids@treasury.gov.ph);

**WHEREAS**, on December 28, 2023, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

- a. recommend the foregoing for the approval of the Officer-in-Charge – Bureau of the Treasury as Head of the Procuring Entity (HOPE).
