**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR  
THE PROCUREMENT OF DATA CENTER INFRASTRUCTURE MANAGEMENT  
SYSTEM (DCIM) FOR THE BUREAU OF THE TREASURY / ITB-25-2023-G**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Data Center Infrastructure Management System (DCIM) for the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Six Million Pesos (PHP 6,000,000.00), inclusive of all applicable taxes;

**WHEREAS**, on October 23, 2023, the Invitation to Bid (ITB) No. 25-2023-G was posted in the Philippine Government Electronic Procurement System (PhilGEPS) BTr website, and to BTr conspicuous places;

**WHEREAS**, on October 31, 2023, two (2) prospective bidders, namely, (1) Eastern Telecommunications, Inc. and; (2) Infobahn Communications, Inc. attended the Pre-bid Conference;

**WHEREAS**, on November 7 & 13, 2023, Supplemental Bid Bulletin Nos. 04-2023 and 14-2023, respectively, were issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

**WHEREAS**, on November 20, 2023, only two (2) bidders: (1) Eastern Telecommunications, Inc. and; (2) Infobahn Communications, Inc. submitted their technical and financial proposals through the [e-bids@treasury.gov.ph](mailto:e-bids@treasury.gov.ph);

**WHEREAS**, on November 20, 2023, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

**WHEREAS**, the BAC resolved to declare Eastern Telecommunications, Inc. ineligible for the project due to non-compliance with ITB Clause 5.3 of Bid Data Sheet;

**WHEREAS**, pursuant to Resolution No. 36-2023 dated November 15, 2023, wherein the BAC declared Infobahn Communications, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification for the Procurement of Data Center Infrastructure Management System (DCIM) for the Bureau of the Treasury / ITB-25-2023-G;

**WHEREAS**, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Infobahn Communications, Inc., the BAC found the same to be responsive and, hence, recommends the award of the contract to Infobahn Communications, Inc.

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Infobahn Communications, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of Data Center Infrastructure Management System (DCIM) for the Bureau of the Treasury / ITB-25-2023-G;
- b. recommend the award for the Procurement of Data Center Infrastructure Management System (DCIM) for the Bureau of the Treasury / ITB-25-2023-G for the Contract Price of Five Million Nine Hundred Ninety-Seven Thousand Eight Hundred Pesos (PHP 5,997,800.00), inclusive of all applicable taxes; and
- c. recommend the foregoing for the approval of the Officer-in-Charge - Bureau of the Treasury as Head of the Procuring Entity (HOPE).
