**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR  
THE SUPPLY OF LABOR AND MATERIALS, TOOLS AND EQUIPMENT AND  
ENGINEERING AND SUPERVISION FOR THE REPAIR AND REHABILITATION OF  
THE BACK-UP POWER SYSTEMS FOR THE BUREAU OF OF THE TREASURY-  
CENTRAL OFFICE / ITB-26-2023-G**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply of Labor and Materials, Tools and Equipment and Engineering and Supervision for the Repair and Rehabilitation of the Back-up Power Systems for the Bureau of of the Treasury - Central Office with an Approved Budget for the Contract (ABC) of Thirteen Million Five Hundred Thousand Pesos (PHP 13,500,000.00), inclusive of all applicable taxes;

**WHEREAS**, on October 23, 2023, the Invitation to Bid (ITB) No. 26-2023-G was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

**WHEREAS**, on October 31, 2023, only one (1) prospective bidder (Renphil Trading) attended the Pre-bid Conference;

**WHEREAS**, on November 7, 2023, Supplemental Bid Bulletin No. 05-2023 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

**WHEREAS**, on November 15, 2023, Renphil Trading submitted its technical and financial proposals through the [e-bids@treasury.gov.ph](mailto:e-bids@treasury.gov.ph);

**WHEREAS**, on the same date, the submitted Technical and Financial Bids of Renphil Trading was opened, read, and calculated as follows:

**WHEREAS**, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Renphil Trading., found the same to be responsive and, hence, recommends the award of the contract to Renphil Trading.

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Renphil Trading as the Single Calculated and Responsive Bidder (SCRB) for the Supply of Labor and Materials, Tools and Equipment and Engineering and Supervision for the Repair and Rehabilitation of the Back-up Power Systems for the Bureau of of the Treasury - Central Office;
- b. recommend the award for the Supply of Labor and Materials, Tools and Equipment and Engineering and Supervision for the Repair and Rehabilitation of the Back-up Power Systems for the Bureau of of the Treasury - Central Office / ITB-26-2023-G for the Contract Price of Thirteen Million Three Hundred Nine Thousand Eight Hundred Ninety-Five Pesos and 20/100 (PHP 13,309,895.20), inclusive of all applicable taxes; and
- c. recommend the foregoing for the approval of the Officer-in-Charge - Bureau of the Treasury as Head of the Procuring Entity (HOPE).
