## DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE THE SUPPLY AND INSTALLATION OF ONE (1) YEAR LICENSE TO EXISTING BACKUP SYSTEM FOR THE BUREAU OF THE TREASURY DATA CENTER OPERATIONS (PHASE 2) / ITB-27-2023-G

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Installation of One (1) Year License to Existing Backup System for the Bureau of the Treasury Data Center Operations (Phase 2) with an Approved Budget for the Contract (ABC) of One Million Six Hundred Thousand Pesos (PHP 1,600,000.00), inclusive of all applicable taxes;

WHEREAS, on October 23, 2023, the Invitation to Bid (ITB) No. 27-2023-G was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

**WHEREAS**, on October 31, 2023, two (2) prospective bidders, namely: (1) Integrated Computer Systems, Inc., and (2) Infobahn Communications, Inc. attended the Pre-bid Conference;

**WHEREAS,** on November 7, 2023, Supplemental Bid Bulletin No. 06-2023 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

**WHEREAS**, on November 15, 2023, Integrated Computer Systems, Inc. submitted its technical and financial proposals through the <u>e-bids@treasury.gov.ph</u>;

**WHEREAS,** on the same date, the submitted Technical and Financial Bids of Integrated Computer Systems, Inc. was opened, read, and calculated as follows:

- b. recommend the award for the Supply and Installation of One (1) Year License to Existing Backup System for the Bureau of the Treasury Data Center Operations (Phase 2) / ITB-27-2023-G for the Contract Price of One Million Five Hundred Nineteen Thousand Eight Hundred Eighty-Seven Pesos (PHP 1,519,887.00), inclusive of all applicable taxes; and
- c. recommend the foregoing for the approval of the Officer-in-Charge, Bureau of the Treasury, as Head of the Procuring Entity (HOPE).
