DECLARING THE POST-DISQUALIFICATION OF INTEGRATED COMPUTER SYSTEMS, INC. AND FAILURE OF BIDDING OF THE PROJECT: SUPPLY AND DELIVERY OF VARIOUS COMPUTER PARTS FOR THE UPGRADE OF THE BUREAU OF THE TREASURY'S WORKSTATIONS / ITB-28-2023-G

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of Various Computer Parts for the Upgrade of the Bureau of the Treasury's Workstations with an Approved Budget for the Contract (ABC) of One Million Five Hundred Seventy-Two Thousand Seven Hundred Fifty Pesos (PHP 1,572,750.00), inclusive of all applicable taxes;

WHEREAS, on October 25, 2023, the Invitation to Bid (ITB) No. 28-2023-G was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on November 6, 2023, two (2) prospective bidders, namely: (1) Joneco Tech Marketing Corporation, and (2) Integrated Computer Systems, Inc. attended the Pre-bid Conference;

WHEREAS, on November 17, 2023, Joneco Tech Marketing Corporation, and Integrated Computer Systems, Inc. submitted their technical and financial proposals through the e-bids@treasury.gov.ph;

WHEREAS, on the same date, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, pursuant to Resolution No. 30-2023 dated November 17, 2023, the BAC declared Integrated Computer Systems, Inc. as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification for the Supply and Delivery of Various Computer Parts for the Upgrade of the Bureau of the Treasury's Workstations;

WHEREAS, following the post-qualification examination, the Technical Working Group (TWG) found that the equipment offered by Integrated Computer Systems, Inc did not meet the minimum requirements specified in the Technical Specifications as contained in the Bidding Documents;

WHEREAS, Integrated Computer Systems, Inc's offer failed to comply on the following specifications:

b. Must be compatible with the Desktop model HP 280 G4 PCI MT Business PC with existing installed memory	b. Kingston KVR25N19S6/4

WHEREAS, based on the Kingston website, the product being proposed by Integrated Computer Systems, Inc. is not included in the list of compatible memory modules for the HP ProDesk 400 G5 MT and HP 280 G4 PCI MT business PC model. Hence, the item being proposed is considered incompatible;

NOW, THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- adopt the TWG Report finding that Integrated Computer Systems, Inc.'s offered equipment as non-compliant with the required Technical Specifications as contained in the Bidding Documents; and
- declare Integrated Computer Systems, Inc. as Post-Disqualified for the Supply and Delivery of Various Computer Parts for the Upgrade of the Bureau of the Treasury's Workstations;
- declare failure of bidding for the Supply and Delivery of Various Computer Parts for the Upgrade of the Bureau of the Treasury's Workstations due to lack of material time to re-bid the project;
