**DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)  
FOR THE DIGITIZATION SERVICE OF THE EXISTING DOCUMENTS FOR THE  
FIELD OFFICES OF THE BUREAU OF THE TREASURY / ITB-29-2023-G**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Digitization Service of the Existing Documents for the Field Offices of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Sixteen Million Pesos (PHP 16,000,000.00), inclusive of all applicable taxes, broken down into three (3) lots, as follows:

Lot 1: PHP 8,749,524.00

Lot 2: PHP 2,670,330.00

Lot 3: PHP 4,580,146.00

**WHEREAS**, on December 4, 2023, the Invitation to Bid (ITB) No. 29-2023-G was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

**WHEREAS**, on December 11, 2023, three (3) prospective bidders, namely: (1) U-Bix Corporation, (2) SVI Information Services Corporation, and (3) Pinnacle Technologies, Inc. attended the Pre-bid Conference;

**WHEREAS**, on December 14, 2023, Supplemental Bid Bulletin No. 15-2023 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

**WHEREAS**, on December 21, 2023, three (3) bidders: U-Bix Corporation, SVI Information Services Corporation, and Pinnacle Technologies, Inc. submitted their technical and financial proposals through the [e-bids@treasury.gov.ph](mailto:e-bids@treasury.gov.ph);

Lot 1: PHP 6,970,457.04

Lot 2: PHP 2,127,363.79

Lot 3: PHP 3,648,851.17
