DECLARING FAILURE OF BIDDING FOR THE PROCUREMENT OF DIGITAL AUTHENTICATION PLATFORM FOR FINANCIAL MANAGEMENT SYSTEMS FOR THE BUREAU OF THE TREASURY / ITB-30-2023-G

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Digital Authentication Platform for Financial Management Systems for the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of One Million Two Hundred Thousand Pesos (PHP1,200,000.00), inclusive of all applicable taxes:

WHEREAS, on December 5, 2023 the Invitation to Bid (ITB) No. 30-2023-G was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on December 12, 2023, only one (1) prospective bidder, Integrated Computer Systems, Inc. attended the Pre-bid Conference;

WHEREAS, on December 22, 2023, no bidder submitted its bids and participated in the Opening of Bids, thus, the BAC is constrained to declare a failure of bidding for the Procurement of Digital Authentication Platform for Financial Management Systems for the Bureau of the Treasury;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED,** as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Procurement of Digital Authentication Platform for Financial Management Systems for the Bureau of the Treasury;
- b. recommend the foregoing for the approval of the Officer-in-Charge, Bureau of the Treasury as Head of the Procuring Entity (HOPE).
