- **Project-specific requirements:**
 - Must submit certification from manufacturer or distributor that the bidder is authorized to bid, sell, support and maintain the products being offered. If distributor will certify the bidder, they must submit certification from Manufacturer acknowledging the distributor as partner of the product being offered.
 - The bidder must be operating in the Philippines for the past Five (5) years as an IT company.
 - The bidder must have Certified Engineer/s for the I.T. Asset Management System being offered and must submit a copy of their certificate/s.
 - The bidder must have 2 similar contracts in the last 5 years.
