**DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR
THE SUPPLY AND INSTALLATION OF 1 YEAR LICENSES TO THE I.T. ASSET
AND PATCH MANAGEMENT SYSTEM OF THE BUREAU OF THE TREASURY /
ITB-20-2024-G**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Installation of 1 Year Licenses to the I.T. Asset and Patch Management System of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Two Million Seven Hundred Eighty-Seven Thousand Pesos (PHP 2,787,000.00), inclusive of all applicable taxes;

WHEREAS, on August 12, 2024, the Invitation to Bid (ITB) No. 20-2024-G was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on August 20, 2024, during the scheduled Pre-Bidding Conference, only one (1) prospective bidder, Systemantech Inc., attended;

WHEREAS, on September 4, 2024, only one (1) bidder, Systemantech Inc., submitted their technical and financial proposals through the e-bids@treasury.gov.ph, however, during the opening of its Technical Bid, Systemantech Inc., failed to comply with the requirements under ITB Clause 19, Section VI. Schedule of Requirements and Section VIII. Checklist of Technical and Financial Documents due to non-submission of schedule of requirements and the audited financial statements for FY 2023 with stamped received by the Bureau of Internal Revenue (BIR);

WHEREAS, after due consideration and deliberation, the BAC is constrained, and thus, resolved to declare a failure of bidding for the Supply and Installation of 1 Year Licenses to the I.T. Asset and Patch Management System of the Bureau of the Treasury due to the ineligibility of the bidder during the preliminary examination;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- declare failure of bidding for the Supply and Installation of 1 Year Licenses to the I.T. Asset and Patch Management System of the Bureau of the Treasury;
- recommend the foregoing for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE); and
