

III. CONDITIONS AND SUPPLIER RESPONSIBITLIES

- 1. Should be new and in perfect condition no torn/missing pages and damages covers
- 2. The delivery shall be within thirty (30) calendar days from the receipt of Purchase Order.
- 3. Warranty: Books found with defects must be replaced with a new copy within thirty (30) days upon receipt of notifications of the defect at no cost to the Bureau.

IV. TERMS OF PAYMENT

Payment shall be made upon the completion of the Service or delivery of Goods in accordance with the signed contract. Payment will be processed through Land Bank's LDDAP-ADA/Bank Transfer facility within thirty (30) days of receipt of the billing statement.

V. APPROVED BUDGET FOR THE CONTRACT (ABC)

The Approved Budget for the Contract (ABC) is **One Hundred Thirty-Five Thousand Pesos (PHP 135,000.00)**, inclusive of all applicable taxes and transport/delivery or other miscellaneous expenses and will be charged against the Bureau's CY 2024 Budget.

VI. MODE OF PROCUREMENT

The mode of procurement is Negotiated Procurement – Small Value Procurement consistent with Section 53.9 of Republic Act No. 9184 and its Revised Implementing Rules and Regulations.
