- Project-specific requirements:
 - Shall submit proof from the manufacturer or distributor that the bidder is authorized to bid, sell, support, and maintain the products being offered. If a distributor certifies the bidder, they must submit certification from the Manufacturer acknowledging the distributor as a partner of the product being offered.
 - Shall submit proof from the manufacturer or distributor that they (manufacturer or distributor) will extend direct technical support to the end-user for the products offered.
 - Shall submit proof that the Bidder is operating in the Philippines for the past five (5) years as an IT company and must submit a **notarized document**.
