RESOLUTION NO. 16-2024

DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE SUPPLY AND INSTALLATION OF 1 YEAR LICENSES TO THE I.T. ASSET AND PATCH MANAGEMENT SYSTEM OF THE BUREAU OF THE TREASURY (REBID) / ITB-21-2024-G

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Installation of 1 Year Licenses to the I.T. Asset and Patch Management System of the Bureau of the Treasury (Rebid) with an Approved Budget for the Contract (ABC) of Two Million Seven Hundred Eighty-Seven Thousand Pesos (PHP 2,787,000.00), inclusive of all applicable taxes;

WHEREAS, on September 10, 2024, the Invitation to Bid (ITB) No. 21-2024-G was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on September 18, 2024, two (2) prospective bidders, namely, 1) Systemantech, Inc., and 2) Pronet Systems Integrated Network Solutions, Inc., attended the Pre-bid Conference;

WHEREAS, on September 30, 2024, only one (1) bidder, Systemantech, Inc., submitted its technical and financial proposals through the e-bids@treasury.gov.ph;

WHEREAS, on September 30, 2024, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, pursuant to Resolution No. 08-2024 dated September 30, 2024, the BAC declared the Systemantech, Inc., as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by the Systemantech, Inc., the BAC found the same to be responsive and recommends the award of the contract to the Systemantech, Inc.;

- a. recommend the foregoing for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE).
