DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE PROCUREMENT OF ONE (1) YEAR SUBSCRIPTION OF WEB APPLICATION FIREWALL LICENSE AND CLOUD CONTENT DELIVERY NETWORK (CDN) WITH ANTI DDoS / ITB-23-2024-G

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of One (1) Year Subscription of Web Application Firewall License and Cloud Content Delivery Network (CDN) with Anti-DDoS with an Approved Budget for the Contract (ABC) of Four Million Pesos (PHP 4,000,000.00), inclusive of all applicable taxes;

WHEREAS, on September 10, 2024, the Invitation to Bid (ITB) No. 23-2024-G was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on September 18, 2024, seven (7) prospective bidders, namely, 1) AGD Infotech, Inc., 2) I-Connect Systems Integration, Inc., 3) PLDT, Inc., 4) Akamai Technologies, 5) Pronet Systems Integrated Network, and 2) Pronet Systems Integrated Network Solutions, Inc., 6) My Busy Bee, Inc., and 7) Exclusive Networks Philippines, Inc., attended the Pre-bid Conference;

WHEREAS, on September 30, 2024, only one (1) bidder, AGD Infotech, Inc., submitted its technical and financial proposals through the e-bids@treasury.gov.ph;

WHEREAS, on September 30, 2024, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, pursuant to Resolution No. 09-2024 dated September 30, 2024, the BAC declared the AGD Infotech, Inc., as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by the AGD Infotech, Inc., the BAC found the same to be responsive and recommends the award of the contract to the AGD Infotech, Inc.;
