DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) FOR THE PROCUREMENT OF VARIOUS ICT EQUIPMENT FOR THE NETWORK REFRESH OF THE BUREAU OF THE TREASURY - PHASE 1 / ITB-25-2024-G

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Various ICT Equipment for the Network Refresh of the Bureau of the Treasury – Phase 1 with an Approved Budget for the Contract (ABC) of Fourteen Million Pesos (PHP 14,000,000.00), inclusive of all applicable taxes;

WHEREAS, on September 10, 2024, the Invitation to Bid (ITB) No. 25-2024-G was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on September 18, 2024, seven (7) prospective bidders, namely, 1) AVLS Data Center Design, 2) Integrated Computer Systems, Inc., 3) Pronet Systems Integrated Network Solution, Inc., 4) Infobahn Communications, Inc., 5) Trends and Technologies, Inc. 6) MEC Networks, Corp., and 7) Questech Co., Inc., attended the Pre-bid Conference:

WHEREAS, on September 23, 2024, and September 25, 2024, Supplemental Bid Bulletin Nos., 01-2024 and 02-2024 were issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

WHEREAS, on October 2, 2024, three (3) bidders, 1) Trends and Technologies, Inc., 2) Integrated Computer Systems, Inc., and 3) Pronet Systems Integrated Network Solution, Inc., submitted their technical and financial proposals through the e-bids@treasury.gov.ph;

WHEREAS, on October 2, 2024, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, Pronet Systems Integrated Network Solution, Inc. was declared ineligible due to its non-submission of the audited financial statements for FY 2023 with stamped received by the Bureau of Internal Revenue (BIR) as required under ITB Clause 19, and Section VIII. Checklist of Technical and Financial Documents;

WHEREAS, pursuant to Resolution No. 11-2024 dated October 2, 2024, the BAC declared Trends and Technologies, Inc., as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation, and verification of all statements made and the legal, technical, and financial documents submitted by Trends and Technologies, Inc., the BAC found the same to be responsive and recommends the award of the contract to Trends and Technologies, Inc.;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Trends and Technologies, Inc., as the Lowest Calculated and Responsive Bidder (LCRB) for the Procurement of Various ICT Equipment for the Network Refresh of the Bureau of the Treasury – Phase 1;
- b. recommend the award for the Procurement of Various ICT Equipment for the Network Refresh of the Bureau of the Treasury Phase 1 for the Contract Price of Eleven Million Four Hundred Ninety-Eight Thousand Two Hundred Fifty-Six Pesos (PHP 11,498,256.00), inclusive of all applicable taxes; and
- a. recommend the foregoing for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE).
