### CONTRACT AGREEMENT

THIS AGREEMENT made on the 16th day of January 2025 between **BUREAU OF THE TREASURY**, with office address at Ayuntamiento Building, Cabildo Street corner Andres Soriano Avenue, Intramuros, Manila 1002 (hereinafter called "the Entity") of the one part and **INTEGRATED COMPUTER SYSTEMS, INC.** with office address at 3<sup>rd</sup> Floor Limketkai Bldg., Ortigas Ave. Greenhills, San Juan City (hereinafter called "the Supplier") of the other part;

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

  <a href="Hundred Thirty-Three Thousand Two Hundred Twenty-Eight (PHP 8,233,228.00">PHILIPPINE Thousand Two Hundred Twenty-Eight (PHP 8,233,228.00)</a>, inclusive of all applicable taxes, or such other sums as may be ascertained, <a href="INTEGRATED COMPUTER SYSTEMS, INC.">INC.</a> agrees to perform and deliver the "Supply and Delivery of One (1) Lot of All-in-One Desktop Computers for the Central Office of the Bureau of the Treasury" in accordance with his/her/its accepted Bid/Quotation/Proposal.</a>
- 4. The **BUREAU OF THE TREASURY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.
