DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) FOR THE SUPPLY AND DELIVERY OF ONE (1) LOT OF ALL-IN-ONE DESKTOP COMPUTERS FOR THE CENTRAL OFFICE OF THE BUREAU OF THE TREASURY / ITB-1-2025-G EPA

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of One (1) Lot of All-in-One Desktop Computers for the Central Office of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Nine Million Three Hundred Eighty Thousand Pesos (PHP 9,380,000.00), inclusive of all applicable taxes;

WHEREAS, on October 8, 2024, the Invitation to Bid (ITB) No. 1-2025-G EPA was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on October 16, 2024, five (5) prospective bidders, namely, 1) Integrated Computer Systems, Inc., 2) Advance Solutions, Inc., 3) Joneco Tech Marketing Corp. 4) ENJ Corp. Asia., and 5) IT Avenue General Merchandise, attended the Pre-bid Conference;

WHEREAS, on October 22, 2024, Supplemental Bid Bulletin No. 06-2024 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

WHEREAS, on October 29, 2024, two (2) bidders namely, 1) Integrated Computer Systems, Inc. and 2) Joneco Tech Marketing Corp., submitted its technical and financial proposals through the <u>e-bids@treasury.gov.ph</u>;

WHEREAS, on October 29, 2024, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

NOW THEREFORE, the Bids and Awards Committee **RESOLVED,** as it hereby **RESOLVES** to:

- a. declare Integrated Computer Systems, Inc. as the Lowest Calculated and Responsive Bidder (LCRB) for the Supply and Delivery of One (1) Lot of All-in-One Desktop Computers for the Central Office of the Bureau of the Treasury;
- b. recommend the award for the Supply and Delivery of One (1) Lot of All-in-One Desktop Computers for the Central Office of the Bureau of the Treasury for the Contract Price of Eight Million Two Hundred Thirty-Three Thousand Two Hundred Twenty-Eight Pesos (PHP 8,233,228.00), inclusive of all applicable taxes; and
- c. recommend the foregoing for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE).
