DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE PROCUREMENT OF GOOGLE WORKSPACE (GWS) LICENSES FOR THE OFFICIAL EMAIL OF THE BUREAU OF THE TREASURY. / ITB-10-2025-G EPA

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Google Workspace (GWS) Licenses for the Official Email of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Six Million Pesos (PHP 6,000,000.00), inclusive of all applicable taxes;

WHEREAS, on December 3, 2024, the Invitation to Bid (ITB) No. 10-2024-G EPA was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on December 11, 2024, four (4) prospective bidders, namely, 1) EZ Tech IT Solutions, 2) ePLDT, Inc., 3) Maroon Studios, and 4) MyBusyBee, Inc., attended the Pre-bid Conference;

WHEREAS, on December 23, 2024, only one (1) bidder, ePLDT, Inc., submitted its technical and financial proposals through the <u>e-bids@treasury.gov.ph</u>;

WHEREAS, on December 23, 2024, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, pursuant to Resolution No. 48-2024 dated December 23, 2024, the BAC declared ePLDT, Inc., as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by ePLDT, Inc., the BAC found the same to be responsive and recommends the award of the contract to ePLDT, Inc.;

- b. recommend the award for the Procurement of Google Workspace (GWS) Licenses for the Official Email of the Bureau of the Treasury for the Contract Price of Five Million Three Hundred Thirty Thousand Six Hundred Sixty-Five Pesos and 71/100 (PHP 5,330,665.71), inclusive of all applicable taxes; and
- c. recommend the foregoing for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE).
