RESOLUTION NO. 50-2024

DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR THE PROCUREMENT OF SUPPORT AND MAINTENANCE SERVICES FOR THE DOCUMENT TRACKING SYSTEM OF THE BUREAU OF THE TREASURY - CENTRAL OFFICE / ITB-12-2025-G EPA

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Support and Maintenance Services for the Document Tracking System of the Bureau of the Treasury – Central Office with an Approved Budget for the Contract (ABC) of Two Million Pesos (PHP 2,000,000.00), inclusive of all applicable taxes;

WHEREAS, on December 3, 2024 the Invitation to Bid (ITB) No. 12-2025-G EPA was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on December 11, 2024, during the scheduled Pre-Bidding Conference, three (3) prospective bidders, namely 1) ISI Icomteq Inc., 2) ePLDT, Inc., and 3) Microgenesis Business Systems, attended;

WHEREAS, on December 23, 2024, only one (1) bidder, Microgenesis Business Systems, submitted its technical and financial proposals through the e-bids@treasury.gov.ph, however, during the opening of its Technical Bid, Microgenesis Business Systems, failed to comply with the requirements under Section VII. Technical Specifications, Statement of Bidder's Existence and Expertise Microgenesis Business Systems did not submit copies of the required training certificates in PHP and MySQL for their engineers;

WHEREAS, after due consideration and deliberation, the BAC is constrained, and thus, resolved to declare a failure of bidding for the Procurement of Support and Maintenance Services for the Document Tracking System of the Bureau of the Treasury – Central Office due to the ineligibility of the bidder during the preliminary examination;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Procurement of Support and Maintenance Services for the Document Tracking System of the Bureau of the Treasury – Central Office;
