DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR THE REPLACEMENT OF AGEING SURVEILLANCE SYSTEM AND ACCESS CONTROL SYSTEM FOR THE BUREAU OF THE TREASURY DATA CENTERS / ITB-13-2025-G EPA

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Replacement of Ageing Surveillance System and Access Control System for the Bureau of the Treasury Data Centers with an Approved Budget for the Contract (ABC) of One Million Nine Hundred Eighty Thousand Pesos (PHP1,980,000.00), inclusive of all applicable taxes;

WHEREAS, on December 3, 2024 the Invitation to Bid (ITB) No. 13-2025-G EPA was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on December 11, 2024, during the scheduled Pre-Bidding Conference, five (5) prospective bidders, namely 1) DGL Veracity Systems Corp., 2) MMBT Telecommunication, 3) Faxcable, Inc., 4) Lightnet Connect Systems Corporation, and 5) Riley Corporation attended;

WHEREAS, on December 23, 2024, no bidder submitted its bids and participated in the Opening of Bids thus, the BAC is constrained to declare a failure of bidding for the Replacement of Ageing Surveillance System and Access Control System for the Bureau of the Treasury Data Centers;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Replacement of Ageing Surveillance System and Access Control System for the Bureau of the Treasury Data Centers;
- b. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings; and
- c. conduct re-bidding of this project.
