DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) FOR THE PROCUREMENT OF DATABASE SOFTWARE LICENSE FOR THE BUREAU OF THE TREASURY / ITB-26-2024-G

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Database Software License for the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Six Million Nine Hundred Forty-Five Thousand Pesos (PHP 6,945,000.00), inclusive of all applicable taxes;

WHEREAS, on October 4, 2024, the Invitation to Bid (ITB) No. 26-2024-G was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on October 14, 2024, three (3) prospective bidders, namely, 1) Radenta Technologies, Inc., 2) Questech Co., Inc., and 3) DBQuest Inc. attended the Pre-bid Conference;

WHEREAS, on October 18, 2024, Supplemental Bid Bulletin No. 03-2024 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

WHEREAS, on October 31, 2024, three (3) bidders namely, 1) DBQuest, Inc., 2) Radenta Technologies, Inc. and 3) Questech Co., Inc. submitted their technical and financial proposals through the e-bids@treasury.gov.ph;

WHEREAS, on October 31, 2024, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, Questech Co., Inc. was declared ineligible due to its due to non-compliance with the required 5-year duration period for the Single Largest Completed Contract;

WHEREAS, pursuant to Resolution No. 27-2024 dated October 31, 2024, the BAC declared the Radenta Technologies, Inc., as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Radenta Technologies, Inc. the BAC found the same to be responsive and recommends the award of the contract to Radenta Technologies, Inc.;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare the Radenta Technologies, Inc., as the Lowest Calculated and Responsive Bidder (LCRB) for the Procurement of Database Software License for the Bureau of the Treasury;
- b. recommend the award for the Procurement of Database Software License for the Bureau of the Treasury for the Contract Price of Five Million Two Hundred Thousand Pesos (PHP 5,200,000.00), inclusive of all applicable taxes; and
- a. recommend the foregoing for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE).
