## DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE SUPPLY AND INSTALLATION OF A NETWORK MONITORING SOFTWARE FOR THE BUREAU OF THE TREASURY ICT OPERATIONS / ITB-3-2025-G EPA

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Installation of a Network Monitoring Software for the Bureau of the Treasury ICT Operations with an Approved Budget for the Contract (ABC) of Two Million Seven Hundred Forty Thousand Pesos (PHP 2,740,000.00), inclusive of all applicable taxes;

WHEREAS, on October 8, 2024, the Invitation to Bid (ITB) No. 3-2025-G EPA posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on October 16, 2024, five (5) prospective bidders, namely, 1) Next Innovation Inc., 2) Dynamic Global Soft, Inc., 3) ACW Distribution (Phils.), Inc., 4) Versatest Solutions and Services, Inc., and 5) Netplay, Inc., attended the Pre-bid Conference:

WHEREAS, on October 29, 2024, two (2) bidders, 1) Next Innovation, Inc., and 2) Dynamic Global Soft, Inc. submitted their technical and financial proposals through the e-bids@treasury.gov.ph;

WHEREAS, on October 29, 2024, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

**WHEREAS,** Dynamic Global Soft, Inc. was declared ineligible due to non-compliance with the similar project required in the Statement of Single Largest Completed Contract (SLCC);

**WHEREAS**, pursuant to Resolution No. 19-2024 dated October 29, 2024, the BAC declared Next Innovation, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Next Innovation, Inc., the BAC found the same to be responsive and recommends the award of the contract to Next Innovation, Inc.;

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Next Innovation, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Supply and Installation of a Network Monitoring Software for the Bureau of the Treasury ICT Operations;
- b. recommend the award for the Supply and Installation of a Network Monitoring Software for the Bureau of the Treasury ICT Operations for the Contract Price of Two Million Four Hundred Eighty-Six Thousand Four Hundred Pesos (PHP 2,486,400.00), inclusive of all applicable taxes; and
- c. recommend the foregoing for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE).
