### **RESOLUTION NO. 47-2024**

#### **DECLARING FAILURE OF BIDDING FOR THE PROCUREMENT OF TWO (2) UNITS MOTOR VEHICLE FOR THE BUREAU OF THE TREASURY CENTRAL OFFICE (RE-BID) / ITB-31-2024-G**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Two (2) Units Motor Vehicle for the Bureau of the Treasury Central Office (Re-bid) with an Approved Budget for the Contract (ABC) of Three Million Four Hundred Ninety Pesos (PHP 3,490,000.00), inclusive of all applicable taxes;

**WHEREAS**, on December 3, 2024, the Invitation to Bid (ITB) No. 31-2024-G was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

**WHEREAS**, on December 11, 2024, during the scheduled Pre-Bidding Conference, only one (1) prospective bidder, Autokid Subic Trading Corporation, attended;

**WHEREAS**, on December 23, 2024, no bidder submitted its bids and participated in the Opening of Bids thus, the BAC is constrained to declare a failure of bidding for the Procurement of Two (2) Units Motor Vehicle for the Bureau of the Treasury Central Office (Re-bid);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Procurement of Two (2) Units Motor Vehicle for the Bureau of the Treasury Central Office (Re-bid);
- b. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings; and
- c. proceed to the Alternative Mode of Procurement.
